

**RESOLUTION**

**IN THE MATTER OF APPROVING SENIOR CITIZEN LEVY ALLOCATIONS FOR 2026**

WHEREAS, the Senior Citizens Levy Advisory Board (SCLAB) met and conducted hearings on February 5th, 2026, during which presentations and information were provided by seventeen (17) social groups and service providers that completed the 2026 Senior Levy Funding application process; and,

WHEREAS, following these hearings, the SCLAB deliberated on the funding amounts to be recommended to the Board of County Commissioners (BOC) for allocation to the various organizations, agencies, and social groups for the year 2026; and

WHEREAS, the SCLAB presented its recommendations at the BOC meeting on Thursday, February 26, 2026 and the BOC reviewed and considered the recommendations provided by the SCLAB; and,

WHEREAS, at this meeting, the Commissioners voted to approve the allocations as recommended by SCLAB; and,

WHEREAS, the approved funding for 2026 will be distributed on a quarterly basis in March, June, September, and December, with the exception of JFS Fiscal & Programmatic Services; NOW, THEREFORE,
